Does the electricity sector have a credibility problem?

Is the sector sleep-walking towards political intervention by failing to address affordability?

Downstream 2025 was notable for explicitly talking about the challenges and problems facing the wider sector. James Kilty set the tone for Downstream in his keynote address, saying the sector has been failing New Zealand by not delivering secure supply at prices that enable our economy to compete and grow. Minister Watts reiterated the point that security of supply and deindustrialisation bring the risk of significant political intervention.

Much of the Downstream Conference then focused on the need for thermal firming and increasing renewable generation. Both of these are critical. But Downstream was notable in not talking about how the sector is driving ever higher prices. You could be forgiven for thinking the sector's general approach is to keep building more and more assets and passing more and more costs onto consumers. The thinking seems to be "if we get through this winter, then the risk of intervention will go away and we can get back to business-as-usual."

But August 2024 was just a moment in time. Wholesale prices for the last 6-7 years were already contributing towards reduced manufacturing and/or gradual deindustrialisation. It's just that last year hastened the process and thereby bought it into sharper focus.

And it is not just our industrial manufacturers. According to the Electricity Authority, average monthly residential bills will double (or more) over the next 5 years. No political party will tolerate that, whether incumbents seeking re-election on the back of promising to get cost-of-living pressures under control, or opposition parties trying to win an election.

For the last 6 – 7 years we have been repeatedly told that we will experience a few years of pain, then prices will start coming down. Every year or so, there is a new reason given for why prices keep climbing – whether political risk under the previous government, the uncertain future of the Tiwai aluminium smelter, investment uncertainty in the face of the Lake Onslow project, etc. Every single time those risks have gone away, prices have not fallen. Not only have prices not fallen, over time they have got worse. Yet nothing has changed – we are still being told to trust that after a few years of pain things will start getting better.

It is hard to find a single person on the consumer side who thinks the wider sector has credibility when it comes to affordability. This seems to be a view increasingly shared by our politicians who are much closer to consumer (voter) sentiment than the sector. A sector response that "we have built some more distribution / transmission / generation" is unlikely to be an acceptable future answer to sustained and increasing high prices.
