## Huntly announcement leaves the door open to political intervention

The agreement is a welcome first step, but it does not go far enough

MEUG welcomed the <u>announcement</u> earlier this week that our four largest generators have reached agreement to extend the life of the third Rankine unit at Huntly (subject to Commerce Commission <u>approval</u>). The agreement is critical to security of supply, ensuring the third Rankine unit is not decommissioned early next year. Alongside maintaining a large stockpile of coal, it will mean firming capacity is not significantly reduced. In that sense it is an important first step.

It is critical that the agreement must not chill new generation build. The current generation pipeline needs to continue to be built, otherwise we will have another lost decade.

If people were expecting or hoping the talks between the large generators would solve our inadequate firming capacity, they would be disappointed. In terms of firming capacity, the agreement means we will not be worse off next year than we are right now. In that sense, the agreement arguably represents the absolute minimum that could have been expected. Failure by our large generators to keep all three Rankine units operational would have been an open invitation for substantive political intervention – not just in firming but more broadly, as it would have provided ammunition to critics arguing that the sector was incapable of resolving even seemingly simple issues.

More needs to be done on firming – a fact that our large generators acknowledge. When our economy starts growing again, we will need more of it. And, when daily winter peak demand tends to be between 9 and 12.5 GWh, ensuring a single 240 MW Rankine unit stays operational does not substantively shift the dial. What we have not seen the sector clearly articulate is how we will increase firming capacity as generators, large and small, make us increasingly reliant on highly intermittent renewables.

In an environment where our large generators often caution against radical political intervention, the fact the sector has not developed a solution to the firming problem means the door remains open to political intervention. It is expected the Frontier Economics report currently before ministers will focus on firming as a critical part to delivering more affordable electricity in the future. If that is so, the report likely provides our politicians with all the rationale they will need to intervene, should they be minded to do so.

In that sense, this week's announcement regards Huntly could come to be seen as a missed opportunity.
